### **Batch A 第A批次**

Subject to the provisions set out in “Other matters”, first come first served. The Vendor does not accept any person having queued up before the Time of the Sale on the date concerned.

以先到先得形式發售，惟受「其他事項」所述的規定限制。賣方不接受相關日期出售時間前在場輪候之人士。

In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

如有任何爭議，賣方保留最終決定權以任何方式（包括抽籤）自行分配任何指明住宅物業予任何有意欲購買的人士。

### **Procedures for Batch A**

#### 第A批次程序

Persons interested in purchasing any of the specified residential properties that will be offered to be sold in Batch A (“Batch A Purchaser”) must follow the following procedures.

有意購買任何在第A批次出售的指明住宅物業的人士(下稱「第A批次買家」)須遵從以下程序。

#### 1. Batch A Purchaser must submit the following:

第A批次買家須遞交:

- (a) Relevant number(s) of cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased. Each cashier order shall be in the amount of HK\$100,000 and made payable to “WONG AND CHAN”. If the Batch A Purchaser has successfully purchased any specified residential property(ies), the said cashier order(s) will be used as part payment of the preliminary deposit(s) for the purchase of the specified residential property(ies) and the balance to be paid by cheque(s). The Batch A Purchaser must bring along blank cheque(s) for payment of balance of preliminary deposit(s).

相關數目的本票，本票的數目須與意欲購買的住宅物業數目相同。每張本票金額為港幣\$100,000及抬頭人為「黃新民律師行」。若第A批次買家成功購買任何指明住宅物業，上述之本票將會全數作為購買指明住宅物業的部份臨時訂金(餘額以支票支付)。第A批次買家請備空白支票以支付臨時訂金餘額。

- (b) A copy of the Batch A Purchaser’s I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s).

第A批次買家的身份證/護照副本或(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單及董事的身份證/護照副本。

2. If a Batch A Purchaser has successfully selected any of the specified residential properties in compliance with the rules set out above, he/she/they/it shall enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected specified residential property(ies). If the Batch A Purchaser does not enter into all Preliminary Agreement(s) for Sale and Purchase of all the selected specified residential properties, he/she/they/it would be deemed to have given up those specified residential properties and his/her/their/its order of priority shall lapse automatically.

第A批次買家根據上述列出的準則成功選擇指明住宅物業後，須就已選擇的指明住宅物業簽署臨時買賣合約。第A批次買家如沒有簽署所有其揀選的指明住宅物業的所有臨時買賣合約，則視為放棄該等指明住宅物業，其優先次序將自動失效。

3. A prospective purchaser interested in participating in Batch A (personally or through a duly authorized attorney of that prospective purchaser who shall produce the original Power of Attorney duly signed by that prospective purchaser and the original identification document of that attorney (the “Attorney”) to the Vendor’s satisfaction and the Vendor reserves the right to accept or reject any Attorney and the Vendor’s decision shall be final) (if the prospective purchaser is a corporation, then one of its directors) must bring along and produce his/her/their original H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate(s) and documents filed with the Companies Registry showing the current list of director(s) and secretary.

有意參與第A批次的準買家（親身或透過其妥為授權之獲授權人（「獲授權人」）（授權人須出示該準買家妥為簽署之授權文件正本及該授權人之身份證明文件正本達致賣方滿意程度，賣方保留權利接納或拒絕任何獲授權人，而該決定為最終。）（如準買家為公司，則該公司其中一個董事）須攜同及出示其香港身份證／護照正本或（如適用）商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。

### **Batch B 第B批次**

Sale by Tender (See details and particulars in the tender notice). The tender notice and other relevant tender documents of the specified residential property will be made available for collection free of charge between 2 p.m. and 6 p.m. from 25 March 2019 daily and up to the closing time of the closing date of the tender at the Sales Office.

### **Batch A 第A批次**

The sale of the specified residential properties is subject to availability. Please note that the completion of the confirmation and verification of a Batch A Purchaser’s identity, any order of priority in respect of the selection of specified residential properties, or the Vendor’s admittance of any person to the Sales Office or a waiting queue does not guarantee that that person will be able to purchase any specified residential property.

### **Batch B 第B批次**

1. The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.

賣方並不承諾亦無責任閱覽、考慮或接受認購任何指明住宅物業最高出價之要約或任何要約。賣方有絕對權利於接受任何要約前於任何時間撤回出售任何指明住宅物業。賣方有全權透過修改及/或發出銷售安排不時更改全部或任何指明住宅物業的招標截止日期及/或時間。

2. The tender of the specified residential properties will proceed in accordance with the Sales Arrangements irrespective of whether any Tropical Cyclone Warning Signal or any Rainstorm Warning Signal is in effect at any time on any date of sale.

3. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within 5 working days after the close of that previous tender exercise.
